

## **Snowventures Terms and Conditions**

### **DEPOSITS AND PAYMENTS:**

An initial minimum deposit of \$500 per person is required at the time of booking. Deposits may vary depending on the package components and vendor requirements. Your representative will confirm the deposit amount at the time of booking. The final balance will be charged to the credit card on file 60 days prior to the date of travel. You may submit a check for final payment in lieu of this final credit card charge. However, it must be received no later than 60 days prior to travel.

### **REVISION FEE:**

There will be a \$25.00 per person change fee for any changes in the original booking plus any applicable airline, lodging or other component fees as a result of the change.

### **CANCELLATIONS:**

All cancellations must be received in writing by SNOWVENTURES. Receipt of cancellation in writing will be considered the cancellation date. The initial deposit is non-refundable. Upon receipt, the final payment is non-refundable, except at the sole discretion of SNOWVENTURES. Some refund may be given to the extent that credit is received from the service providers.

### **INSURANCE:**

Trip cancellation insurance is highly recommended. Contact your agent for details.

### **CURRENCY FLUCTUATION:**

All rates for international tours are based on exchange rates at the time of booking and are subject to change in the case of currency fluctuations and/or price increases by suppliers. SNOWVENTURES can guarantee prices only for bookings that have been paid in full. SNOWVENTURES will not and is under no obligation to, provide a "grace period" during which time bookings that have not been paid in full, may be paid in full for the purpose of qualifying for the price guarantee.
